



## GRAYMERE COUNTRY CLUB MEMBERSHIP OPPORTUNITIES 2024

### FULL GOLF MEMBERSHIP – Ages 40 +

Provides full access to all club facilities and amenities, including the championship 18-hole golf course, pro shop, swimming pool, clubhouse, dining rooms, all social-related events and activities. Includes full voting privileges.

**INITIATION FEE: \$10,000      MONTHLY DUES: \$400**

### JUNIOR GOLF MEMBERSHIP – Ages 21 to 39

Provides full access to all club facilities and amenities, including the championship 18-hole golf course, pro shop, swimming pool, clubhouse, dining rooms, all social-related events and activities. Includes full voting privileges.

**INITIATION FEE: \$10,000** (\$5,000 due at time of application. Remaining \$5,000 due upon 40<sup>th</sup> birthday)

**MONTHLY DUES: \$240**

### OUT OF AREA MEMBERSHIP

Available to candidates whose primary residence is outside of a 40-mile radius from the club. Provides full access to all club facilities and amenities, including the championship 18-hole golf course, pro shop, swimming pool, clubhouse, dining rooms, all social-related events and activities.

**INITIATION FEE: \$10,000      MONTHLY DUES: \$240**

### SOCIAL MEMBERSHIP – Ages 40 +

Provides access to club facilities and amenities to include swimming pool, dining rooms, bar, and all social-related events and activities

**INITIATION FEE: \$2,000      MONTHLY DUES: \$240**

### JUNIOR SOCIAL MEMBERSHIP – Ages 21 to 39

Provides access to club facilities and amenities to include swimming pool, dining rooms, bar, and all social-related events and activities

**INITIATION FEE: \$1,000      MONTHLY DUES: \$144**

### DINING MEMBERSHIP

Provides access to club dining rooms, bar, and all dining events (only).

**INITIATION FEE: \$1,000      MONTHLY DUES: \$100**

### CORPORATE MEMBERSHIP

A business entity may become a member under any of the membership classes with only one initiation fee. Up to five memberships may be included under one corporation.

**INITIATION FEE: \$12,500      MONTHLY DUES: Corresponds with type of membership.**

\*All “NEW” members are required to be set up for automatic withdrawal for monthly billings (ACH). After the first twelve months, if not delinquent, member may opt out of automatic withdrawal.

\*All memberships, excluding Out of Area, are subject to a **Food & Beverage Minimum of \$225 per calendar quarter**. No member may join the club for a period of less than one year or as the Board of Directors may determine. All dues and fees are subject to Tennessee Amusement Tax of 9.75%.
